- (2) This restricted stock unit award was granted on May 24, 2012 as an automatic, nondiscretionary award under the Company's 2011 Equity Incentive Plan upon the reporting person's reelection to the Company's Board at the Company's 2012 Annual Meeting of Stockholders. The award vests in four (4) equal installments on each of the first four (4) three-month anniversaries of the grant date. 5,000 of these restricted stock units were converted on a one-for-one basis into shares of Polycom, Inc. common stock following the vesting on 2/24/2013.
