This award vests as to 3,333 shares on November 25, 2013, 5,000 shares on February 24, 2014, and 5,000 shares on May 26, 2014. 5,000 of these restricted stock units were converted on a one-for-one basis into shares of Polycom, Inc. common stock following the vesting on February 24, 2014.
