- (2) This restricted stock unit award was granted on October 23, 2013 as an automatic, nondiscretionary award under the Company's 2011 Equity Incentive Plan to a Nonemployee Director upon his/her initial appointment or election to the Board. This award vests as to 3,333 shares on November 25, 2013, 5,000 shares on February 24, 2014, and 5,000 shares on May 26, 2014. 5,000 of these restricted stock units were converted on a one-for-one basis into shares of Polycom, Inc. common stock following the vesting on May 26, 2014.
